### About the course

With the formal introduction of Court-Annexed Mediation, it is in the interest of attorneys to familiarise themselves with the process and techniques of mediation. This 5-day course deals specifically with divorce mediation. Divorce mediation requires attorneys who are personable and articulate and who have good listening skills. For effective mediation, it is also advantageous if the attorney has practical experience in working with divorcing couples.

Whether you wish to practise as a mediator or be in a position to advise your clients or represent them at mediations, you will benefit greatly from attending the course.

## Accreditation

The event conforms to the **standards for Court-Annexed Mediation** published by the Department of Justice and Constitutional Development and accredited by the National Board of Family Mediators (NABFAM). Please note that participants will be entitled to apply for accreditation as divorce mediators and not as court mediators, which requires other training.

**IMPORTANT:** All participants are required to attend the **full 40-hour (5-day) course** for which they will receive from LEAD a Certificate of Attendance. This will enable them to apply to their local service provider for accreditation as Divorce Mediators. Participants who fail to attend the full event will not receive a Certificate of Attendance.
