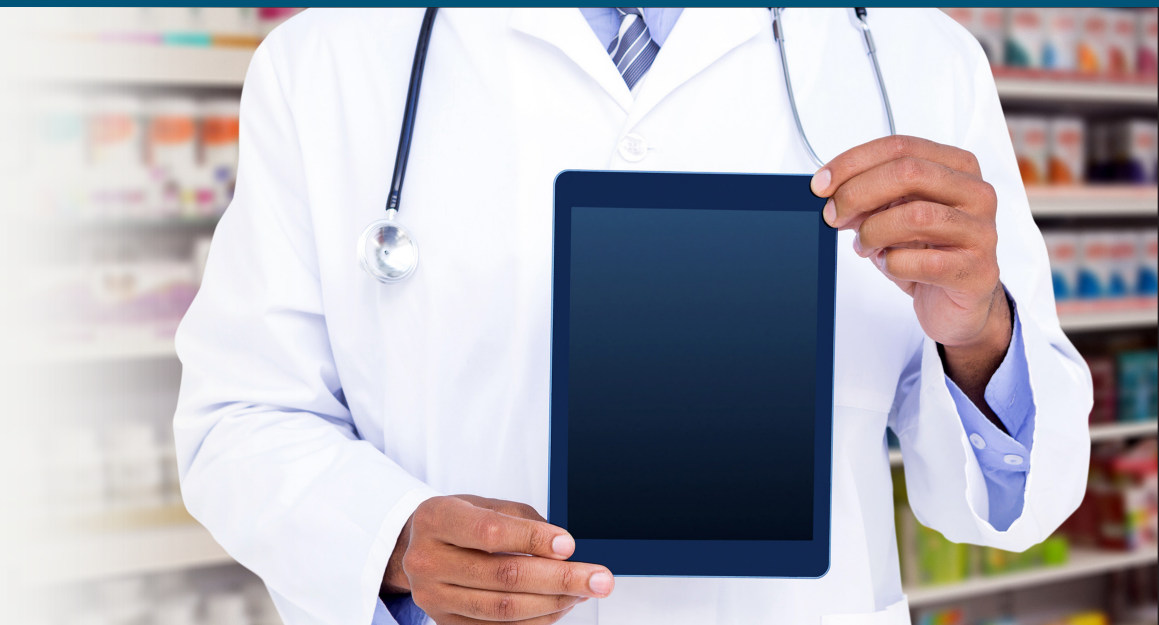

INTRODUCTION TO MEDICAL LAW

Online Course for Attorneys and Candidate Attorneys 2018 What you need to know now and for the future

About this course

This course focuses on the basic principles in medical law and specifically medical negligence. Increasingly, more attorneys are pursuing these types of claims without having received training in this *sui generis* type of delict – the principles of which differs from other delicts. Participants will learn, amongst other things, about these differences and how to approach litigation in medical law in a practical manner.

This three-month course is exclusively presented online and there are no contact sessions. It is a flexible equivalent to a full-time, three-day, attendance course.

Who should register?

This course is essential for all practising attorneys venturing into the field of medical negligence.

Candidate attorneys who have not done the new online **PLT Introduction to Medical Law Course** are also encouraged complete this course.

Course material

The online course consists of three webinars, each focusing on a specific requirement of medical negligence and aspects of Medical Law in general. The material is presented in an interactive format, supplemented by written material for downloading from eLEADer – LEAD's online learning portal.

You will be expected to test your own knowledge by way of a self-assessment after each module as well as completing a written assignment. This e-course is presented in English only and all assignments must be submitted in English.

Learning outcomes

- Understanding the basic concepts of Medical Law and Health Care law.
- The legal position and effect of the hospital/doctor and patient relationship.
- Understanding the term 'medical negligence', and how it impacts on civil and criminal litigation?
- Understanding the various grounds of justification for medical interventions and other general defences in Medical law.
- The influence of legislation on the practice of medicine and access to health care.
- The Constitution and its impact on health care and access to health care services in South Africa.
